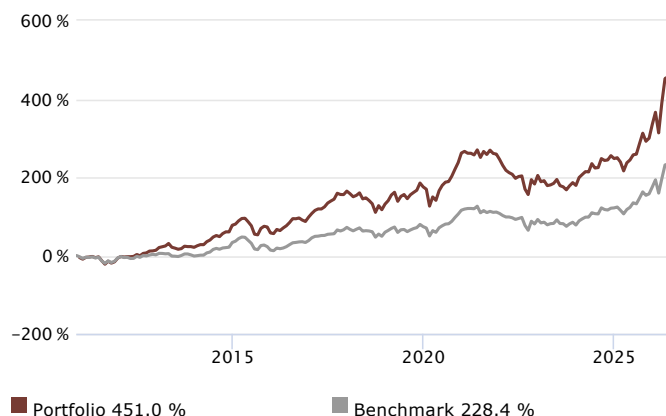
GROSS OF FEES IN EUR AS OF 31 AUGUST 2026

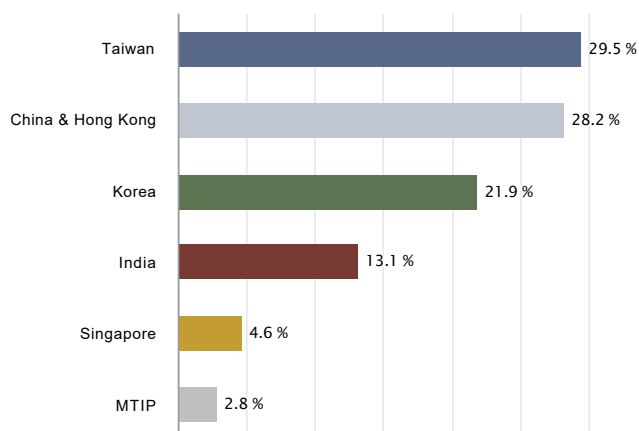
