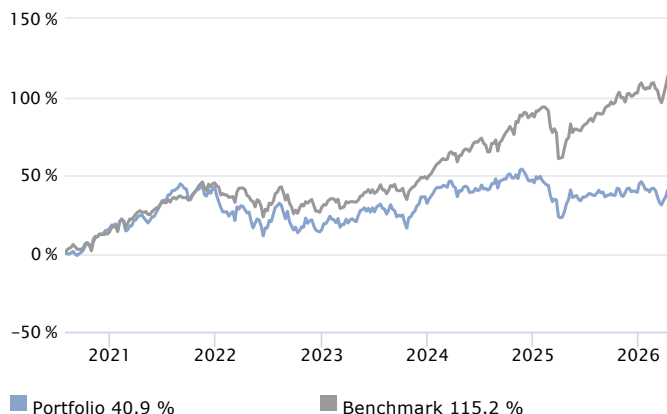
GROSS OF FEES IN EUR AS OF 30 APRIL 2026

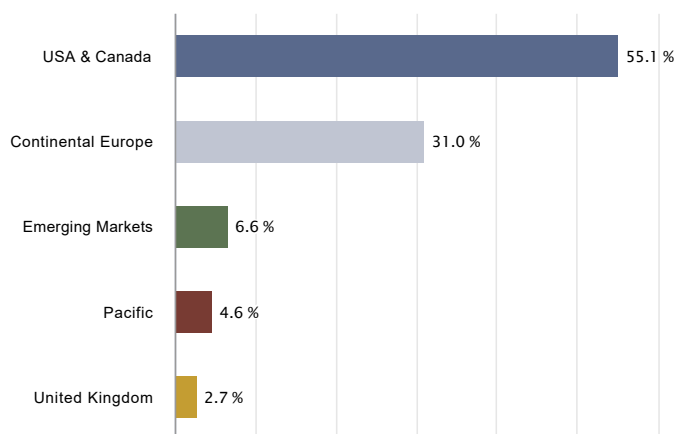
