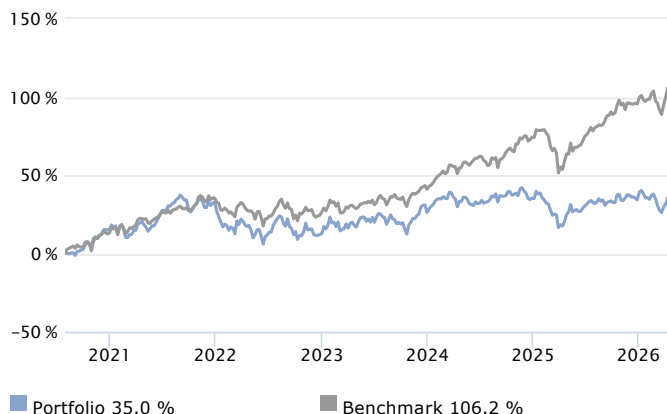
GROSS OF FEES IN GBP AS OF 30 APRIL 2026

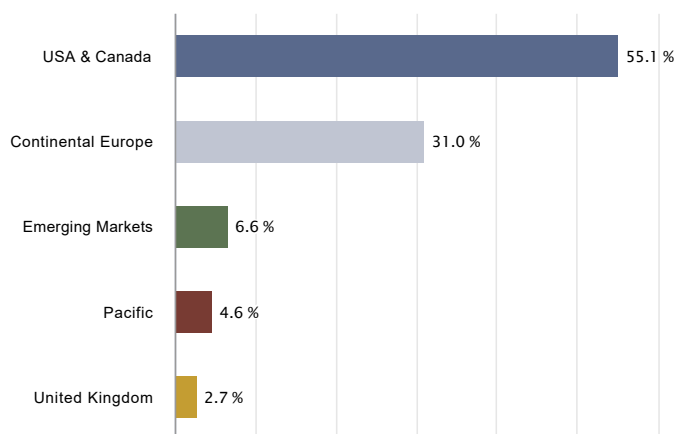
