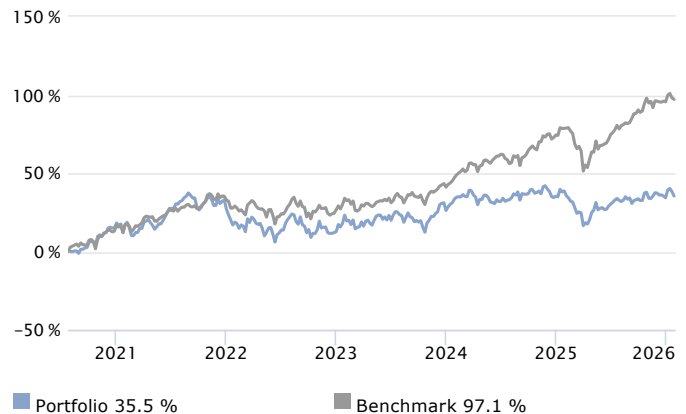
GROSS OF FEES IN GBP AS OF 31 JANUARY 2026

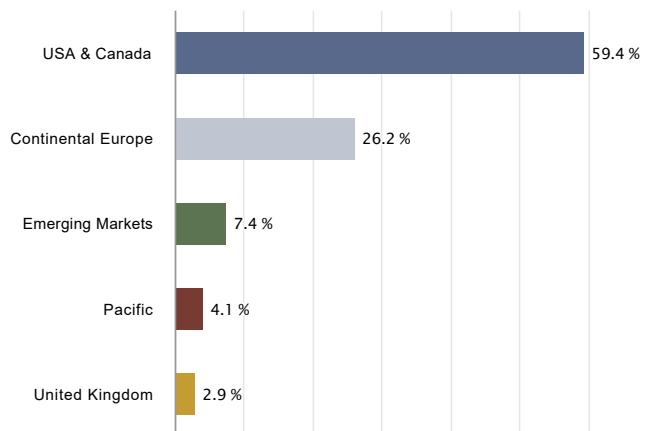
