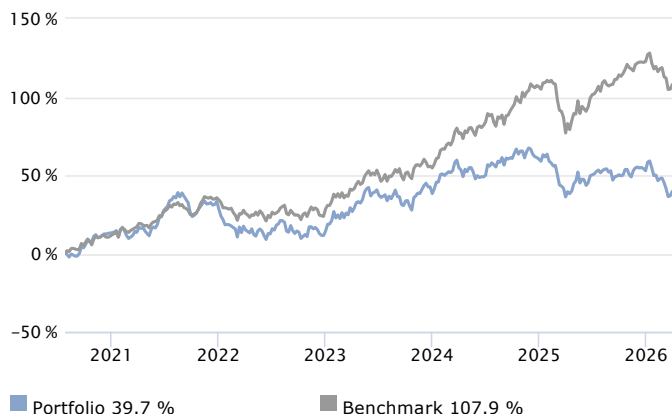
GROSS OF FEES IN NOK AS OF 31 MARCH 2026

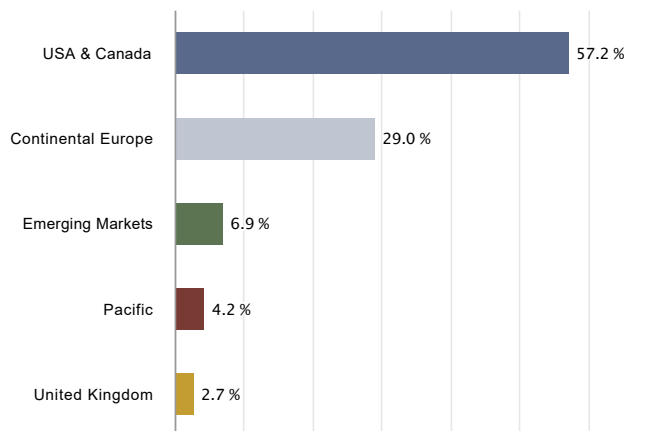
