C WORLDWIDE EMERGING MARKETS COMPOSITE

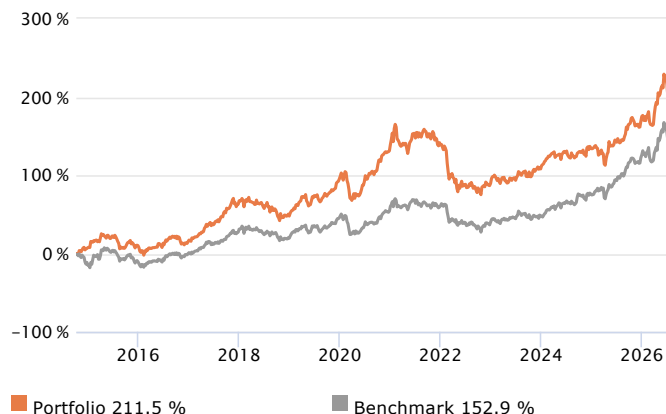
GROSS OF FEES IN AUD AS OF 31 AUGUST 2026

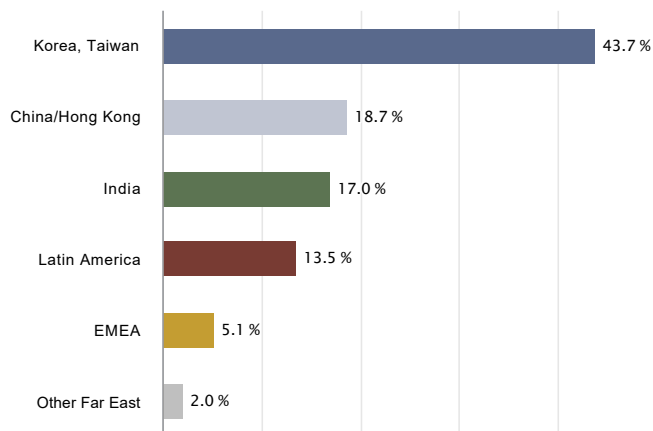
