# C WORLDWIDE EMERGING MARKETS COMPOSITE

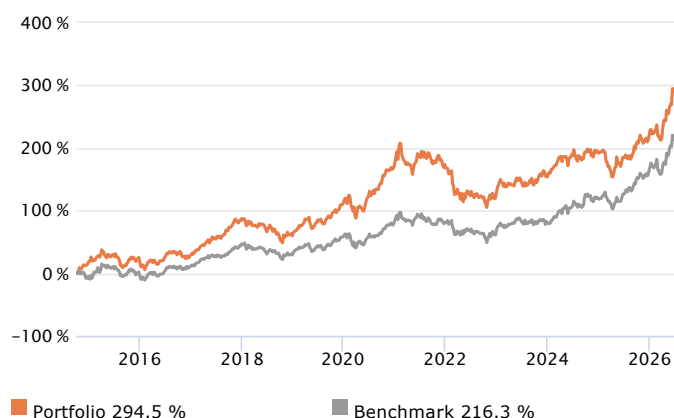
GROSS OF FEES IN NOK AS OF 30 JUNE 2026

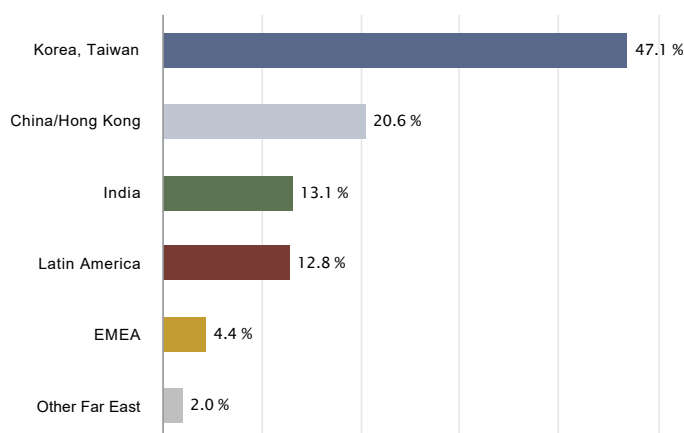
