C WORLDWIDE EMERGING MARKETS COMPOSITE

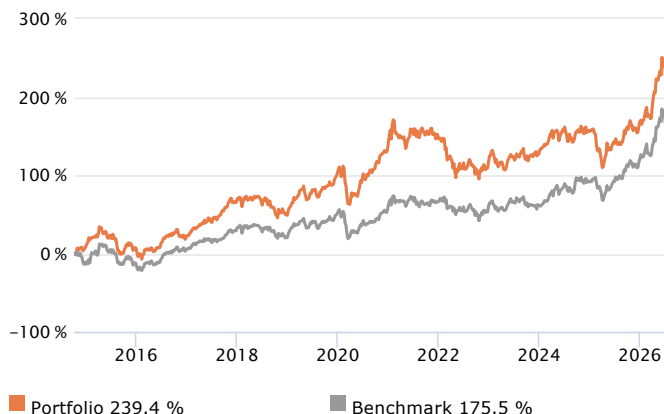
GROSS OF FEES IN SEK AS OF 31 AUGUST 2026

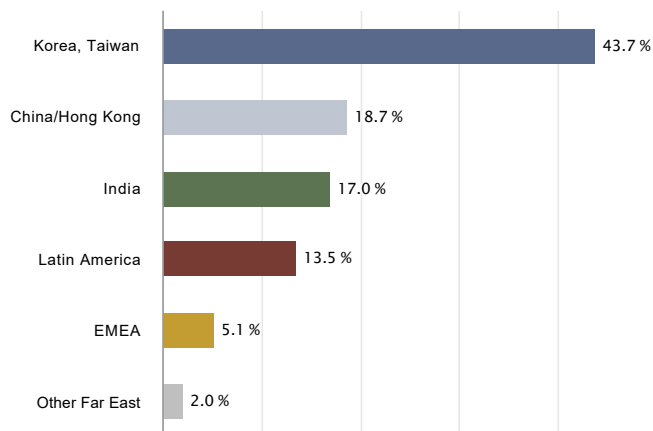
