C WORLDWIDE SWEDEN SMALL CAP COMPOSITE

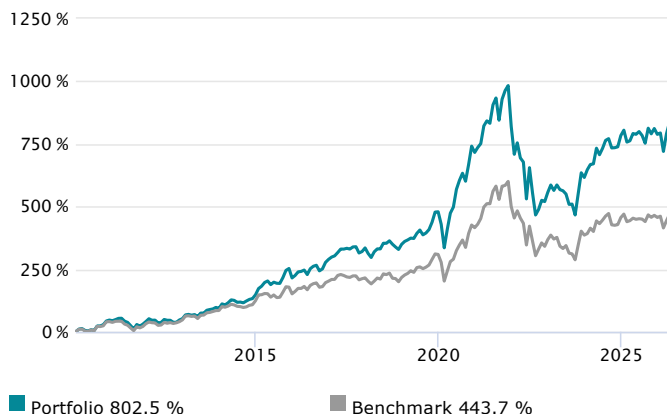
GROSS OF FEES IN EUR AS OF 30 JUNE 2026

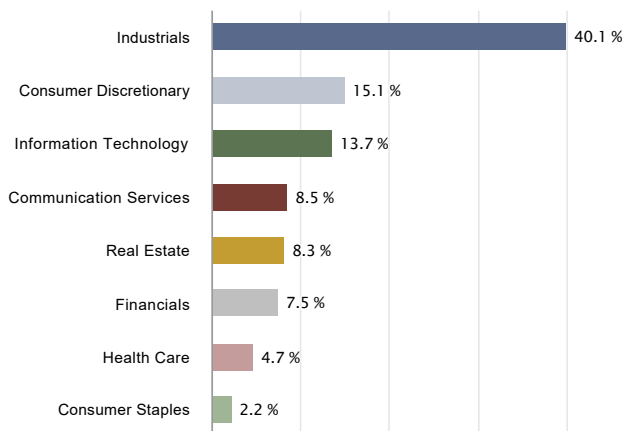
