C WORLDWIDE SWEDEN SMALL CAP COMPOSITE

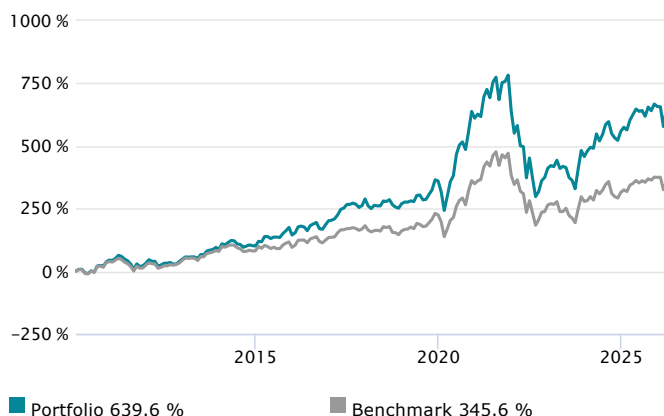
GROSS OF FEES IN USD AS OF 30 JUNE 2026

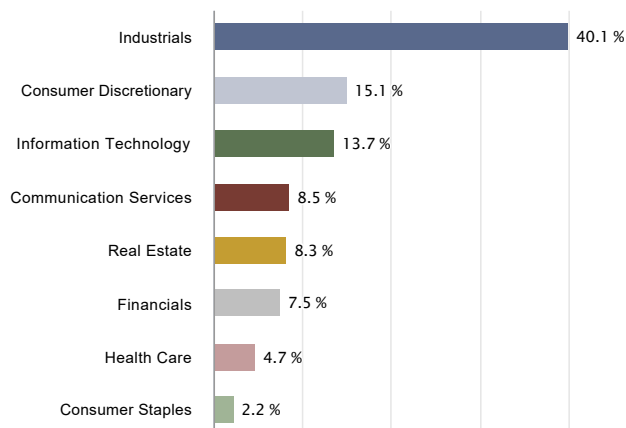
